CASA recruits, screens and trains volunteers to look out for the best interests of children who have been removed from their homes by the child welfare system due to abuse or neglect and placed in out-of-home placements (foster homes, group homes or residential facilities). While the children are living in out-of-home placements, the volunteers advocate in court for needed services to address the children's mental, dental, educational, mental health, life skills and recreational needs. The volunteers advocate with the ultimate goal of finding the children safe and permanent families and homes.

The use of trained volunteers is essential to the mission of CASA. The volunteers (advocates) undergo rigorous training for 32 hours before they can serve as an advocate. Volunteers will work an estimated 10-12 hours each month. During the year ended June 30, 2014 the hours worked were 15,803. The time has an estimated value of \$400,290. This estimate is based on the volunteer hourly value as determined by the Independent Sector which places the value of a New Jersey volunteer at \$ 25.33 an hour. This amount is not reflected as program service expense on the Form 990 but represents a significant part of CASA's program services since the volunteers are working directly with the children.
