INTRODUCTION

CASA for Children of Mercer and Burlington Counties Celebrates Its 20th Anniversary!

In 1977, a Seattle Superior Court Judge was concerned about having to make decisions on behalf of abused and neglected children without enough information. He conceived the idea of appointing community volunteers to independently investigate the cases, make recommendations, and speak up in court about what was in the best interest of the child. He made a request for volunteers; 50 citizens responded, and that was the start of the CASA movement.

Twenty years ago CASA of Mercer County joined that movement, making a commitment to serve local children in Foster Care. In 2011, CASA of Burlington merged with CASA of Mercer to more effectively serve foster children in our area. And we certainly have.

Since we began CASA of Mercer and Burlington Counties has served close to 4,000 local foster children.

We accomplished this through the efforts of over 3,000 extensively trained community volunteers. While these numbers are impressive, the impact of this work on the lives of CASA children is incalculable.
